

**PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY,
ASSUMPTION OF RISK AND INDEMNITY AGREEMENT**

I, _____, of legal age, HEREBY give my consent for my child _____, or any child in my care, control, custody or supervision to participate in events organized by **OUT THERE SPORTS AND RECREATION**, a social organization for gays, lesbian, bisexuals, and transgendered (GLBT) individuals and those who are GLBT friendly.

I fully understand that activities undertaken by **OUT THERE SPORTS AND RECREATION** and in any future events, activities, and sports, including but not limited to, hiking, trekking, wall or rock climbing, ice hockey, floor hockey, Ultimate, bowling, tennis, kayaking and camping can be physically demanding and potentially dangerous. I wish to allow my child, or any child in my care, control, custody or supervision, to participate in these activities knowing that they are potentially dangerous.

I accept and assume all risks of injury, including death, to my child, or any child in my care, control, custody or supervision, or to my property or myself. I represent and warrant that I have the authority to give this release. I represent and warrant that the said child is in good physical condition sufficient to engage in the activities.

I HEREBY release, and discharge OUT THERE SPORTS AND RECREATION, its organizers, officers, members, directors, agents or employees and their respective personal representatives, assigns, heirs, next-of-kin (the “**Releasees**”), from all liability to me, or my child, or any child in my care, control, custody or supervision, their respective personal representatives, assigns, heirs, and next-of-kin from any and all claims, demands, losses or damages on account of any injury, including, but not limited to, death caused or alleged to be caused, in whole or in part, by the Releasees.

IF despite this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, I, my child, or any child in my care, control, custody or supervision, makes a claim against any of the Releasees named above, **I agree to indemnify and save and hold harmless the Releasees** and each of them from any litigation, expenses, attorney fees, loss, liability, damage or costs they may incur due to the claim made against any of the Releasees named above whether the claim is based on the negligence of the Releasees or otherwise.

I sign this Agreement on my own behalf and on behalf of my child, or any child in my care, control, custody or supervision. By signing this, Parental Consent, Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, I fully understand that this Agreement is valid to all future events, activities and sports undertaken by Out There Sports and Recreation and its Releasees named above.

I have read this Parental Consent, Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, and understand that by signing it I give up substantial rights that I or my child, or any child in my care, control, custody or supervision, would otherwise have to recover damages for loss occasioned by the Releasees’ fault, and sign it voluntarily and without inducement. I also hereby acknowledge my full understanding of the foregoing and specifically waive any requirement for independent legal advice.
